Article I - Name

## B. Eligibility

1. All officers must be enrolled students in good standing at Lake Superior College.

E. Removal
8. An officer may be removed at any time with or without cause by a $2 / 3$ majority vote of the total voting membership.
9. Automatic removal of officers shall occur if eligibility standards are not maintained or if academic or behavioral probation or suspension is imposed upon the officer.

## Article V. Committees

## A. Standing Committees

1. The Executive Committee shall be comprised of the elected officers of the organization and shall meet to prepare agenda items and informational reports, and to collaborate on the business of the organization. The Executive Committee may, with a majority vote, authorize expenditures of up to $\$ 150.00$ for routine operational expenses.
